- Stock prices reversed up 0.5% to recover the losses recorded on mid-week supported by medium and top ten capitalization counters which were up 0.9% each. NSE 20 stocks gained the least at 0.1%. High average sector gains of 2.4%, 1.9% and 1.7% were witnessed in the insurance, the Investment and the Construction sectors.
- The market value traded jumped 71.1% up from KES 481.789Mn to KES 824.47Mn despite a 3.0% decline on the volumes traded from 46.49Mn to 45.09Mn shares as the market focused on high priced counters.
- The telecommunication, Safaricom, regained back her top mover position after exchanging KES 451.00Mn from 23.86Mn shares while its price stabilized at KES 18.90 per share. The telco's average foreign activity jumped up from 67.2% to 91.1%, dominated by foreign sales at 96.4% and foreign buys of 85.7%.
- Banks followed in the market top movers list led by KCB Group, Stanbic, HF Group and Standard Chartered Bank, to take the
  next four positions in the top five market movers list, find values in the below table.
- Kenya Airways maintained a top loser position, after shedding 10.0% loss from KES 5.60 to KES 6.22 per share after a speculative rally witnessed on its first two weeks of trading after the suspension lift.
