Daily Market Wrap

- Stock prices were relatively stable on Tuesday, January 28, 2025, going up minimally at 0.1% on average. NSE 10 and NSE 25 remained stable while NSE 20 shed 0.2%. Market activity however improved 76.4% to trade 24.92Mn shares with a focus on high value stocks to double the value traded at 246.5% to KES 590.60Mn.
- The banking, telecommunication and the manufacturing sectors remained the focus of investors to transact 37.1%, 34.4% and 16.7% of the day's turnovers. Cumulative the three sectors moved 88.3% of the market value, pointing out to the investors' attention.
- Safaricom regained back her top mover position after changing hands 10.78Mn shares of KES 203.13Mn while its price moved 0.3% up from KES 18.85 to KES 18.85 per share. The stock remains among our top long-term stock recommendations.
- EABL took second mover position with KES 97.18Mn from 504,000 shares ahead of its half year 2025 results expected on Friday, 31st January 2025. Watch out for our update.
- Banks followed to occupy the net three position led by Equity Group, KCB Group and Stanbic Group.
