Daily Market Wrap

- Equities prices were up 0.6% on the second last trading day of the year 2024 on last mile transactions supported by expectations of better earnings for 2024.
- The market activity, however, remained low to move 7.77Mn shares valued at KES 160.28Mn.
- Foreign participation rose sharply from 1.0% on Friday last week to 37.4% on Monday, December 30, 2024.
- Market attention remained on the banking sector to push the sector's average price up by 0.9% on average. Equity Group, KCB Group and DTBK took the top three market mover positions with values of KES 54.63Mn, KES 38.38Mn and KES 27.32Mn respectively. These three banks saw their prices soar 1.8% to KES 47.00, 0.1% to KES 40.00 and 1.1% to KES 69.00 per share for Equity Group, KCB Group and DTBK respectively.
- In the first quarter of 2025 we anticipate a continued upward rally in the banking sector as their valuations have already edged higher on better Q3-2024 financials.
