### Daily Market Wrap 18<sup>th</sup> February 2025

#### **Daily Market Wrap**

- Equities price further went up 0.6% on Tuesday, February 18, 2025, elevated mainly by gains in the low/small capitalization counters. NSE 10 gained 0.3% ass NSE 25 gathered 0.5% while NSE 20 remained flat at 2,223.99 points.
- The day's market activity however, dipped 36.7% from 27.25Mn to transact 17.25Mn shares and thereby pulling the value traded 11.7% down to KES 302.24Mn.
- Sector wise performance saw the banking sector overtake the telecommunications after trading only 4.09Mn shares valued at KES 169.89Mn. This was led by continued attention on KCB Group which transacted KES 89.71Mn from 1.99Mn shares and Equity Group which traded 0.81Mn shares of KES 37.80Mn. The banking sector's price improved marginally at an average of 0.1% in the day.
- Safaricom took second top mover position after exchanging KES 68.87MN from 3.68Mn shares to further push its price 1.1% up from KES 18.50 to KES 18.70 per share.
- The secondary bonds market remained active to traded KES 36.25Bn from 218 deals, a 287.8% jump from KES 9.35Bn of 96 transactions traded on Monday. The fast rise in value in bonds activity follows entry of the re-opened infrastructure bond papers, IFB1/2022/14 and IFB1/2023/17, which re-entered the secondary bonds market trading yesterday. This is as investors who missed try in the primary auction take early positions to avoid higher premiums as interest rates narrow down.
