Daily Market Wrap

- NSE equities' prices were down 1.2% on Wednesday, January 29, 2025, despite a 17.6% rise in market activity. NSE 10 as NSE 25 shed 0.7% each as NSE 20 gained 0.2%. This is even as we expect market activity to improve in the remaining two days of January on end month book closures by the corporates.
- The telecommunication, the banking and the manufacturing sectors remained the day's top movers with turnovers of KES 245.91Mn, KES 209.71Mn and KES 70.85Mn respectively, to account for 95.9% of the total market value.
- Foreign participation improved from 56.3% to 77.7% with a reduced net foreign outflows on improved inflows.
- Safaricom retained the top mover position with KES 245.91Mn value from 13.44Mn shares of KES 18.30 average price per share. The telco giant lost 2.9% from KES 18.85 to KES 18.30 per share on increased foreign exits from the counter in the day.
- Banks took second mover position led by Stanbic with KES 89.09Mn value from 640,900 shares. Overall banking stocks lost 0.3% losses on HF Group, NCBA and KCB which lost 4.,1%, 1.5% and 1.0% respectively, find below price movements.
