Daily Market Wrap

- Stocks prices relaxed down on Wednesday, March 12, 2025, to shed 0.5% on average even the FY2024 banking financials continue being unveiled. All the four indices edged down led by NSE 20 and NSE 25 which shrunk 0.6% each while NSE 10 and all share index (NASI) lost 0.5% each.
- The day's value traded dipped 30.3% from KES 543.56Bn to KES 378.87Bn impacted by concentration on low priced counters. This is as the shares traded fell marginally at 0.6% from 21.56Mn to 21.43Mn shares.
- Market foreign activity improved from 31.6% to 47.6% as foreign exits maintained especially on Safaricom and KCB which contributed a combined KES 103.38Mn net foreign outflows against a market net foreign outflow of KES 102.27Mn. As a result, Safaricom and KCB emerged top movers with KES 210.11Mn and KES 64.13Mn from 11,71Mn and from 1.45Mn shares respectively.
- KCB Group reported a 64.8% jump on its profits after tax to KES 61.8Bn for the year 2024 financial year compared to KES 37.5Bn reported in full year 2023. The top tier 1 Bank declared a KES 1.50 final dividend for a total dividend of KES 3.00 per share for 2024. The Bank's management signaled to a possible special divided considering the better financials and the anticipated conclusion of the National Bank of Kenya sale. In view of these expectations, we anticipate lender's price to remain unchanged from the current market price.
- Secondary bonds dipped 43.2% from KES 15.41Bn to KES 8.76Bn even as investors position themselves ahead of further rate cuts.
