Daily Market Wrap

- Market Indicators: The equities market closed with a mixed performance, with the NASI falling 0.82% to 176.82 points, while the NSE 20 gained 0.24% to 2,975.81 points. The NSE 10 eased 0.22% to 1,754.62 points, as the NSE 25 was nearly unchanged, inching up 0.02% to 4,556.57 points. Market capitalization slipped 0.82% to Kes. 2,785.76Bn, driven by weaker sentiment, as trading volumes declined 12.23% to 42.11Mn shares. Equities turnover more than halved to Kes. 583.53Mn from Kes. 1,275.55Mn in the prior session.
- Gainers/Losers: Kenya Airways (+9.45%), Home Afrika (+8.89%), and Kakuzi (+8.46%) led the gainers. On the flip side, StanChart (-9.92%) slid after the Supreme Court upheld a pension dispute ruling that could cost the lender over Kes. 7.00Bn, while Kenya Re's share price dropped (-5.36%) following the 21-day suspension of its Managing Director amid internal governance reviews. Sameer Africa (-5.12%) and Safaricom (-2.34%) also posted losses, alongside Longhorn Publishers (-5.69%).
- **Top Movers:** In terms of activity, Safaricom remained the top mover with Kes. 354.50Mn in turnover, followed by Co-op Bank (Kes. 176.38Mn), StanChart Bank Kenya (Kes. 143.64Mn), Stanbic Holdings (Kes. 126.20Mn), and DTB Group (Kes. 120.42Mn).
- Foreigners' Participation: Foreign investors showed mixed activity, with Equity Group and Safaricom leading trades. Net inflows were recorded in DTB Group (Kes 2.44Mn), Equity Group (Kes 1.65Mn), BAT (Kes 0.58Mn), and StanChart (Kes 0.50Mn). Outflows were dominated by Umeme (-Kes 15.62m), KenGen (-Kes 12.70m), KCB (-Kes 9.60m), KPLC (-Kes 7.24Mn), and EABL (-Kes 6.62Mn), reflecting continued selling in utilities and banking counters.
- Bonds Market: The secondary bond market recorded a turnover of Kes. 5.46Bn, down 27.88% from Kes. 7.57Bn in the previous session, with deals declining to 112 from 182. Activity was led by IFB1/2018/15Yr (Kes. 700.00Mn), FXB1/2022/25Yr (Kes. 674.00Mn), and FXB1/2022/19Yr (Kes. 558.00Mn).
- Market Update: Foreign investors turned net sellers in the week ending September 5, 2025, offloading Kes. 1.00Bn mainly from Safaricom (Kes. 936.00Mn) and select banking counters, reversing August's strong inflows. The exits reflected profit-taking after Safaricom hit a three-year high and highlighted persistent volatility in foreign participation at the NSE. The recent sell-off signals portfolio managers locking in gains ahead of third-quarter earnings, highlighting the continued volatility of foreign participation at the NSE.
