Daily Market Wrap

- Market Indicators: The equities market closed lower, with NASI down 0.63% to 178.70, NSE20 slipping 0.34% to 3,018.59, and NSE25 easing 0.25% to 4,626.94. Market capitalization dipped 0.07% to Kes. 2,815.23Bn, as trading slowed with volumes dropping 66.95% to 14.10Mn shares and turnover down 67.18% to Kes. 297.76Mn.
- Gainers/Losers: TPS Eastern Africa (+7.27%), Eaagads (+6.82%), and Express Kenya (+4.72%) led the gainers,
 while Sameer Africa (-8.74%), Carbacid (-8.22%), and BOC Kenya (-5.46%) topped the losers.
- **Top Movers:** Activity was driven by KCB Group (Kes. 123.56Mn), Absa NewGold ETF (Kes. 43.90Mn), and StanChart Bank (Kes. 27.41Mn).
- Foreign Participation: Safaricom recorded the highest net inflows at Kes. 4.19Mn, followed by StanChart (Kes. 2.13Mn) and Jubilee Holdings (Kes. 1.80Mn), while Absa NewGold ETF (-Kes. 43.90Mn) led outflows, alongside Umeme (-Kes. 2.67Mn) and Equity Group (-Kes. 2.50Mn).
- Bonds Market: The secondary bond market recorded lower activity, with turnover easing 6.24% to Kes. 7.21Bn from Kes. 7.69Bn in the previous session. Deals also dipped slightly to 181 from 188, reflecting cautious investor participation amid steady liquidity in the fixed income segment.
- Market Update: Centum Investment increased its stake in Akiira Geothermal to 85.00% through a Kes. 233.00Mn buyout, lifting its total investment to over Kes. 2.20Bn. With Kes. 3.50Bn already spent on drilling two wells, Akiira now seeks new financing to progress development. The move underscores Centum's push into energy diversification, with investor optimism hinging on the project's ability to attract partners and achieve commercial viability.
- Meanwhile, the National Treasury plans to reopen 36 bonds in FY 2025/26, targeting Kes. 40–60Bn monthly issues and introducing only one new 25-year bond in May 2026. The strategy aims to ease debt service costs by leveraging lower-coupon reopenings, offering investors attractive medium- to long-term yields alongside improved liquidity.
