Daily Market Wrap

- The stock market experienced a marginal increase in the share prices. The overall prices (NASI) increased by
 0.78% with all other NSE tracking indicators gaining.
- The value of equities turnover declined by 21.59% from Kes. 746.09Mn on 14th August 2025 to Kes. 585.04 on 15th August 2025. Similarly, the volumes traded during the day dipped by 25.16% from 29.77Mn shares in 14th August 2025 to 22.28Mn shares in 15th August 2025.
- The focus of the stock market remained on Telecommunication, Banking, and Manufacturing sectors transacting Kes. 231.21Mn, Kes. 185.41Mn, and Kes. 115.09Mn of market turnover respectively.
- The day's top movers were Safaricom, EABL, and Equity Group with market turnovers totaling Kes. 231.21Mn, Kes. 113.69Mn, and Kes. 115.09Mn respectively.
- Co-operative Bank Group Plc reported their H1 2025 results on 14th August 2025. The lender realized an 8.3% increase in profit before tax (PBT) from Kes. 18.2Bn in H1 2024 to Kes. 19.7Bn in H1 2025. The bank's profit after tax (PAT) rose by 8.4% to Kes. 14.1Bn from Kes. 13.0Bn realized during H1 2024. The strong financial performance for the period H1 2025 has been largely attributed to a significant growth in key areas that include assets, equity, and customer deposits.
