Daily Market Wrap

- Market Indicators: The equities market closed bearish as NASI fell 0.87% to 173.50, NSE 20 declined 1.44% to 2903.15, and NSE 25 shed 1.15% to 4499.62; market capitalization slipped 0.87% to Kes. 2,733.52Bn, with volumes increasing 57.55% to 18.89Mn shares and turnover rising 51.95% to Kes. 573.32Mn.
- Gainers/Losers: Limuru Tea (+9.92%) led gainers alongside TP Eastern Africa (+5.31%) and Eaagads Ltd (+4.99%), while Home Afrika (-9.68%) retained the top loser spot, followed by CIC Insurance (-8.28%) and Absa Group (-6.59%).
- **Top Movers:** Trading activity was dominated by Equity Group (Kes. 335.69Mn), KCB Group (Kes. 78.03Mn), and Safaricom (Kes. 38.71Mn), with Jubilee Holdings (Kes. 26.99Mn) and KenGen (Kes. 19.66Mn) also featuring.
- Foreign Participation: Foreign investors were net buyers, with DTB Group and Absa Group leading inflows at Kes. 6.73Mn and Kes. 0.01Mn respectively, while outflows were seen in Equity Group (-Kes. 15.57Mn), Safaricom (-Kes. 11.49Mn), and KenGen (-Kes. 1.80Mn).
- Bonds Market: The secondary bond market registered increased activity today, with turnover rising by 5.96% to Kes. 8.35Bn from Kes. 7.88Bn in the previous session.
- Market Update: The Capital Markets Authority has exempted NPRT Holdings Africa Ltd from making a mandatory takeover bid for Nation Media Group (NMG), paving the way for the Aga Khan Fund for Economic Development (AKFED) to transfer its 54.08 % stake—92.62 Mn shares—to its wholly owned Kenyan subsidiary as part of an internal reorganisation. NPRT says it will not buy additional shares, and NMG will remain listed on the Nairobi, Uganda, Rwanda, and Dar es Salaam exchanges. With no change in ultimate ownership or strategy, the move is largely administrative and should have minimal impact on NMG's share price, though it signals a commitment to a stronger local corporate structure.
