Daily Market Wrap

- All share indices surged up on 20th August 2025 with NASI, NSE20, and NSE 25 increasing by 0.94%, 1.02%, and 0.78% respectively.
- The value of equities increased by 114.68% to Kes. 886.81Mn turnover with a 156.57% increase in volumes traded to 39.23Mn equity trades.
- The market focused on Banking, Telecommunication, and Manufacturing sectors transacting Kes. 621.09Mn, Kes. 87.19Mn, and Kes. 85.21Mn of market turnover respectively.
- Flame Tree Group, NSE, and Eaagads Ltd featured in the day's top gainer's list with a price change of 9.16%, 9.13%, and 8.79% respectively.
- The top movers comprised of KCB Group, Equity Group, and Safaricom, pulling a market turnover of Kes. 342.53Mn, Kes. 118.17Mn, and Kes. 87.19Mn.
- Equity Group had the most active foreign buy counter with a turnover of Kes. 72.92Mn. On the other hand, Scan
 Group topped in the foreign sells transacting Kes. 14.50Mn.
- The secondary bond market activities increased by 101.88% from Kes. 12.78Bn on 19th August 2025 to Kes. 25.80Bn on 20th August 2025. FXD1/2020/15Yr, IFB1/2022/19Yr, and IFB/2018/15Yr were the most traded with Kes. 2.18Bn, Kes. 1.03Bn, and Kes. 1.00Bn turnover respectively.
- KCB Group Plc initiated talks aimed at expanding its operations in Ethiopia by acquiring 40% in an unnamed Ethiopian Bank. The discussions to enter the Ethiopian market comes after the Ethiopian government allowed foreign banks to operate in the country from June 2025. The decision to expand to Ethiopia is strategic as it positions KCB to benefit from first-mover competitive advantage in a market that had been previously untapped due to state protectionism. Potential investors should consider a BUY on KCB stock for long term as it explores growth avenues through regional expansion.
