#### **Daily Market Wrap**

- All market share indices increased on 22<sup>nd</sup> August 2025 with NASI, NSE20, and NSE25 gaining by 0.69%, 0.93%, and 0.37% respectively.
- The market turnover for equities dropped by 4.20% from Kes. 530.67Mn on 21<sup>st</sup> August 2025 to Kes. 508.38Mn on 22<sup>nd</sup> August 2025 with a 7.61% increase in volumes traded from 23.93Mn to 25.75Mn trades on 22<sup>nd</sup> August 2025.
- The market focused more on the Telecommunication, Banking, and Energy & Petroleum sectors with market turnovers worth Kes. 269.66Mn, Kes. 163.98Mn, and Kes. 26.41Mn respectively.
- The day's top movers comprised of Safaricom, Equity Group, and KCB Group after transacting Kes. 269.66Mn, Kes. 86.60Mn, and Kes. 42.11Mn of market turnover respectively.
- Foreigners' participation- the Telecommunication sector continued to dominate in foreign sells and foreign buys with a market turnover of Kes. 226.56 and Kes. 255.75Mn respectively. Equity Group topped in foreigner's net inflows with Kes. 49.47Mn as Umeme Group dominated in foreigner's net outflows with Kes. 1.84Mn.
- The secondary bond market declined by 50.30% in market turnover from Kes. 8.29Bn on 21st August 2025 to Kes. 4.12Bn on 22nd August 2025. The most traded bonds were FXD1/2020/15Yr and FXD1/2018/15Yr with 700Mn and 260Mn market turnover respectively.
- Sanlam Kenya Plc released their first half of 2025 financial results. The insurer reported an 89.03% decrease in profit after tax (PAT) from Kes. 282.21Mn in H1 2024 to Kes. 30.96Mn in H1 2025. Profit before tax (PBT) reduced sharply by 89.90% from Kes. 494.54Mn in H1 2024 to Kes. 49.95Mn in H1 2025. The company's weak performance was driven by a swing to loss related to net finance expenses from insurance contracts which rose by 73.37% from Kes. 1.69Mn in H1 2024 to Kes. 2.93Mn in H1 2025. During this period, the insurer completed a recapitalization and debt payment initiative, reshaping the key elements of the balance sheet. The insurer's share price has since dropped by 5.85%.
