### Daily Market Wrap 30<sup>th</sup> September 2025

#### **Daily Market Wrap**

- Market Indicators: The equities market closed positive, with NASI up 0.03% to 176.74, NSE10 gaining 0.36% to 1,783.31, NSE20 adding 0.28% to 2,972.64, and NSE25 rising 0.26% to 4,624.72. Market capitalization edged up 0.03% to Kes. 2,784.47Bn, while activity surged as turnover rose 253.73% to Kes. 535.80Mn.
- Gainers/Losers: Kapchorua Tea (+9.43%), Express Kenya (+9.39%), and Williamson Tea (+3.97%) led gainers,
   while Home Afrika (-6.06%), Flame Tree (-4.76%), and Sameer Africa (-4.46%) topped the losers.
- **Top Movers:** Safaricom dominated trades with Kes. 317.28Mn in turnover, followed by KenGen (Kes. 32.19Mn), KCB Group (Kes. 27.48Mn), KPLC (Kes. 26.12Mn), and Williamson Tea (Kes. 16.57Mn).
- Foreign Participation: Foreign investors were net sellers, with Safaricom posting the largest outflows at -Kes. 254.93Mn, followed by Umeme (-Kes. 12.66Mn) and Stanbic (-Kes. 5.76Mn). Equity Group led net inflows at Kes. 11.67Mn, followed by DTB (Kes. 9.86Mn) and KCB (Kes. 3.57Mn).
- Bonds Market: Activity in the secondary bonds market declined, with turnover falling 15.10% to Kes. 11.86Bn from Kes. 13.97Bn in the previous session, reflecting mild profit-taking after recent gains.
- Market Update: Britam Holdings Plc released its H1 2025 financial results, reporting a decline in profit before tax to Kes. 2.50Bn from Kes. 2.80Bn in H1 2024. Profit after tax fell 13.43% to Kes. 1.74Bn, while basic EPS dipped 15.00% to Kes. 0.68 from Kes. 0.80 in H1 2024. Despite the decline in earnings, insurance revenue rose 11.00% to Kes. 19.69Bn, and interest and dividend income grew 16.00% to Kes. 10.59Bn, supported by stronger portfolio management and investment realignment. The balance sheet remained solid, with total assets at Kes. 225.02Bn (H1 2024: Kes. 208.53Bn) and shareholder equity improving to Kes. 31.25Bn from Kes. 29.46Bn in December 2024. The board did not declare an interim dividend.

Britam remains cautiously optimistic for H2 2025, banking on stabilizing interest rates and improving macroeconomic conditions to support earnings recovery
