Daily Market Wrap

- Market Indicators: The equities market closed on a bearish note, with NASI down 0.79% to 171.21, NSE 10 falling 0.57% to 1,748.08, NSE 20 easing 0.23% to 2,935.11, and NSE 25 shedding 0.46% to 4,564.51. The Banking Index slipped slightly by 0.17% to 165.59. Market capitalization declined to Kes. 2,697.36Bn, while total equities turnover fell 26.03% to Kes. 308.06Mn.
- Gainers/Losers: Absa NewGold ETF led the gainers' list, advancing 8.37%, followed by Uchumi Supermarket at 5.41% and Home Afrika at 5.17%. On the losing end, Sameer Africa dropped 6.93%, E.A. Portland Cement fell 5.86%, while Sanlam Kenya declined 5.72%.
- **Top Movers:** Safaricom dominated trading with Kes. 104.25Mn, followed by KPLC with Kes. 34.89Mn and KCB Group at Kes. 34.83Mn.
- Foreign Participation: Foreign investors were net sellers, recording heavy outflows led by Safaricom (Kes. 11.32Mn), KenGen (Kes. 27.09Mn), and DTB Group (Kes. 1.94Mn). Inflows were concentrated in KCB Group (Kes. 28.70Mn), I&M Group (Kes. 0.47Mn), and Kenya Power (Kes. 0.35Mn).
- Bonds Market: Activity in the secondary bond market weakened, with turnover down 36.17% to Kes. 5.56Bn,
 reflecting reduced investor engagement compared to the previous session.
- Market Update: East African Breweries PLC (EABL) announced plans to redeem its Kes. 11.00Bn Medium Term Notes ahead of schedule under its 2021 MTN Programme. The early redemption, set for 29th October 2025, will cover the full principal amount plus accrued interest up to that date, payable to noteholders on record as of 14th October 2025. Once completed, the Notes will be delisted from the Nairobi Securities Exchange's Fixed Income Market Segment, marking the conclusion of EABL's MTN Programme.

The early redemption underscores EABL's strong liquidity and sound balance sheet management, signaling the company's ability to meet its debt obligations ahead of schedule. This move is likely to enhance investor confidence in the firm's credit profile and governance standards while freeing up borrowing capacity for future capital-raising initiatives. It also reflects positively on the issuer's long-term financial health, potentially improving sentiment around EABL's equity performance.
