### Daily Market Wrap 14<sup>th</sup> October 2025

#### **Daily Market Wrap**

- Market Indicators: The equities market closed on a mixed note, with NASI declining 0.51% to 170.34, NSE 10 easing 0.61% to 1,737.49, and the Banking Index falling 0.86% to 164.16. However, the NSE 20 and NSE 25 indices edged up 0.14% and 0.18% to 2,939.16 and 4,572.87 respectively. Market capitalization slipped to Kes. 2,683.74Bn, while equities turnover rose slightly by 0.16% to Kes. 308.54Mn.
- Gainers/Losers: BK Group led the gainers with a rise of 8.44%, followed by NCBA Group at 8.27% and Sanlam Kenya at 8.25%. On the losing side, Williamson Tea dropped sharply by 21.19%, Shri Krishna Overseas declined 9.29%, while Centum fell 7.31%.
- **Top Movers:** Safaricom remained the most traded counter with Kes. 66.06Mn, followed by Kenya Power at Kes. 49.46Mn and KenGen at Kes. 46.50Mn.
- Foreign Participation: Foreign investors were net sellers, with major outflows from Safaricom at Kes. 20.09Mn, Absa NewGold ETF at Kes. 9.58Mn, and Stanbic Holdings at Kes. 6.55Mn. Inflows were led by KCB Group at Kes. 35.29Mn, Equity Group at Kes. 9.74Mn, and Kenya Power at Kes. 2.80Mn.
- **Bonds Market:** Activity in the secondary bonds market strengthened significantly, with turnover surging 96.76% to Kes. 10.95Bn from Kes. 5.56Bn in the previous session, reflecting renewed investor appetite for fixed-income securities.
