Daily Market Wrap

- Market Indicators: The equities market closed on a positive note, with all major indices edging higher except the Banking Index. NASI rose 1.12% to 172.24, NSE 10 gained 0.16% to 1,740.24, NSE 20 advanced 0.39% to 2,950.65, and NSE 25 climbed 0.86% to 4,612.06. The Banking Index eased 0.87% to 162.74. Market capitalization increased to Kes. 2,713.59 Bn, while total equities turnover fell 11.59% to Kes. 272.77 Mn.
- **Top Gainers/Losers:** Shri Krishna Overseas (+9.97%) led the gainers, followed by NCBA Group (+7.97%) and Longhorn Publishers (+5.67%). On the losing end, Kapchorua Tea (-9.96%) and Williamson Tea (-9.87%) topped the decliners, while Kenya Power (-5.81%) also slipped on profit-taking.
- **Top Movers:** Safaricom dominated trading with Kes. 104.05Mn in turnover, followed by KCB Group (Kes. 34.68Mn) and KenGen (Kes. 33.37Mn), underscoring continued interest in the telecom and banking sectors.
- Foreign Participation: Foreign investors were net buyers, posting inflows in Safaricom (+Kes. 36.62Mn), KCB Group (+Kes. 11.39Mn), and Equity Group (+Kes. 8.95Mn), while outflows were seen in Absa NewGold ETF (-Kes. 32.82Mn) and KenGen (-Kes. 8.39Mn).
- Bonds Market: Activity in the bonds segment softened, with turnover declining 31.96% to Kes. 7.45Bn from Kes. 10.95Bn in the previous session.
- Market Update: Kenyans will enjoy another month of stable fuel prices, with EPRA maintaining Super Petrol at Kes. 184.52, Diesel at Kes. 171.47, and Kerosene at Kes. 154.78 in Nairobi, and similar stability across major towns. Last month saw minor reductions, while July's hike was linked to higher global freight costs. Looking ahead, steady international oil prices and controlled import costs suggest fuel prices are likely to remain stable in the near term, supporting predictable operating costs for businesses and consumers alike. This stability is expected to provide a positive environment for consumer spending and overall market confidence.
