Daily Market Wrap

- Market Indicators: The equities market closed on a positive note, with NASI up 0.45% to 178.96, NSE 10 rising 0.45% to 1,794.31, NSE 20 gaining 0.62% to 3,004.28, and NSE 25 advancing 0.45% to 4,672.29. The Banking Index edged down 0.45% to 164.85. Market capitalization increased to Kes. 2,819.56Bn, while turnover declined 8.15% to Kes. 443.61Mn.
- Gainers/Losers: Longhorn Publishers (+8.91%) led gainers, followed by Williamson Tea (+7.19%) and Crown Paints (+5.60%). Uchumi Supermarket (-4.88%), Flame Tree Group (-3.57%), and Kapchorua Tea (-2.25%) topped the losers.
- **Top Movers:** Safaricom dominated activity with Kes. 218.76Mn, followed by KPLC (Kes. 49.47Mn) and KCB Group (Kes. 43.03Mn).
- Foreign Participation: Foreign investors were net buyers, with strong inflows into Safaricom (Kes. 137.00Mn), KCB (Kes. 36.73Mn) and Equity Group (Kes. 25.08Mn). Outflows were led by KPLC (-Kes. 14.07Mn) and KenGen (-Kes. 7.38Mn).
- Bonds Market: The secondary bond market recorded lower activity, with turnover falling 32.97% to Kes. 5.47Bn from Kes. 8.16Bn the previous session, indicating a pullback in investor participation after recent strong trading.
- Market Update: Kenya's National Assembly has approved the partial privatization of Kenya Pipeline Company (KPC), allowing the government to sell up to 65.00% of its stake while retaining 35.00%. The IPO, expected to raise Kes. 100.00 Bn (\$1.15 Bn), will fund development spending, pending bills, and debt management. Key safeguards include Auditor General audits, capped adviser fees (Kes. 100.00 Mn), and priority allocations for youth, women, and persons with disabilities. While offering a rare investment in strategic infrastructure, risks remain from litigation, valuation disputes, high interest rates, and potential fuel tariff increases. The KPC IPO provides a unique opportunity to invest in a critical national infrastructure asset with strong government support and potential for stable long-term returns.
