#### **Daily Market Wrap**

- Market Indicators: The equities market closed positive, with NASI rising 0.36% to 178.36, NSE 10 up 0.15% to 1,783.78, NSE 20 advancing 0.13% to 3,010.70, and NSE 25 gaining 0.65% to 4,776.45. The Banking Index eased 0.96% to 157.60. Market capitalization increased to Kes. 2,809.98Bn, while equities turnover declined 12.84% to Kes. 865.23Mn.
- Top Gainers/Losers: NCBA Group led gainers, climbing 5.48%, followed by WPP Scangroup at 5.45% and Flame

  Tree Group at 4.96%, buoyed by renewed investor demand. On the losing end, Kapchorua Tea dropped 9.94%,

  Express Kenya declined 7.75%, and BK Group shed 5.59%.
- **Top Movers:** Equity Group dominated trading with Kes. 480.49Mn, followed by Safaricom at Kes. 119.07Mn and KCB Group at Kes. 76.56Mn, indicating sustained interest in large-cap banking and telecom stocks.
- Foreign Participation: Foreign investors were net sellers, with notable outflows from Safaricom (Kes. 31.77Mn), Stanbic Holdings (Kes. 19.88Mn), and Absa NewGold ETF (Kes. 2.52Mn). Inflows were concentrated in Equity Group (Kes. 31.04Mn), EABL (Kes. 10.45Mn), and KCB Group (Kes. 9.83Mn), showing selective foreign accumulation in banking and consumer stocks.
- Bonds Market: The secondary bond market segment recorded a sharp rise in activity, with turnover jumping 665.81% to Kes. 20.83Bn, reflecting heightened investor appetite for long-dated government papers after a recent decline.
