### **Daily Market Wrap**

- Market Indicators: The equities market closed mixed, with NASI slipping 0.26% to 178.50, NSE 10 easing 0.23% to 1,790.15, and NSE 25 marginally lower by 0.07% to 4,668.95. In contrast, NSE 20 advanced 0.89% to 3,030.95. The Banking Index edged down 0.15% to 164.60. Market capitalization declined 0.26% to Kes. 2,812.18Bn, even as turnover rose 9.00% to Kes. 483.55Mn, supported by heightened activity in select counters.
- Gainers/Losers: KenGen (+9.65%) topped the day's gainers, followed by Olympia Capital (+9.32%) and Car & General (+8.59%). On the flip side, Unga Group (-4.18%), Sameer Africa (-2.88%), and Longhorn Publishers (-2.42%) led the losers.
- **Top Movers:** KCB Group was the most active counter, posting Kes. 99.37Mn in turnover. Williamson Tea followed with Kes. 73.42Mn, while KPLC traded Kes. 50.14Mn. KenGen (Kes. 45.71Mn) and Safaricom (Kes. 41.51Mn) also featured prominently among the top movers.
- Foreign Participation: Foreign investors were net buyers, with strong inflows into Safaricom (Kes. 187.18Mn), KPLC (Kes. 4.31Mn), and DTB Group (Kes. 1.05Mn). Outflows were recorded in KCB (-Kes. 41.50Mn), Equity Group (-Kes. 11.67Mn), and EABL (-Kes. 7.65Mn), highlighting selective positioning.
- Bonds Market: The secondary bond market recorded subdued activity, with turnover falling 47.71% to Kes.
   2.86Bn from Kes. 5.47Bn the previous session, reflecting a significant drop in investor participation.
- Market Update: Kenya has launched a \$1.00 Bn (Kes. 129.23 Bn) buyback of its Eurobond maturing in February 2028, the third such early redemption in recent years, aimed at easing repayment pressures and smoothing debt maturities. The buyback will be funded by a new Eurobond issuance split into seven-year and 12-year tranches maturing in 2033 and 2038, with investors offered 103.75% of principal plus accrued interest. This follows earlier buybacks of \$1.50 Bn in 2024 and \$579.00 Mn in March 2025, reflecting Treasury's proactive debt management amid high servicing costs, and total public debt exceeding Kes. 11.91 Trn. The move supports near-term liquidity and signals policy credibility, but rising borrowing costs above 9.00% and Kenya's elevated debt levels warrant cautious positioning.
