Daily Market Wrap 13th November 2025

Market Indicators: The equities market closed mixed, with NASI edging up 0.12% to 187.34, while NSE 10, NSE 20, and NSE 25 slipped 0.08%, 0.29%, and 0.25% to 1,944.76, 3,174.51, and 5,047.06 respectively. The Banking Index dipped 0.16% to 203.30. Market capitalization inched up to Kes. 2,956.50Bn, while total equity turnover rose 40.52% to Kes. 849.03Mn, driven by increased trading activity.

Gainers/Losers: Uchumi Supermarket led gainers, rallying 10.00%, followed by Co-operative Bank (+9.45%) and Crown Paints (+5.26%). On the downside, ABSA Bank shed 6.38%, Flame Tree Group declined 5.78%, and Nation Media Group fell 5.24%.

Top Movers: Safaricom remained the day's most traded counter with Kes. 304.07Mn in turnover, followed by KCB Group (Kes. 144.46Mn) and EABL (Kes. 98.81Mn).

Foreign Participation: Foreign investors were net sellers, recording notable outflows in Safaricom (Kes. - 194.81Mn), Jubilee Holdings (Kes. -6.56Mn), and Equity Group (Kes. -4.66Mn). However, inflows were recorded in KCB Group (Kes. 96.34Mn), DTB Group (Kes. 2.52Mn), and BAT Kenya (Kes. 0.31Mn).

Bonds Market: Activity in the secondary bonds market weakened, with turnover easing 24.98% to Kes. 11.65Bn from Kes. 15.53Bn in the previous session.

Market Updates:

- Co-operative Bank of Kenya posted a 12.1% increase in profit before tax to Kes. 30.03Bn for the nine months ended September 2025, up from Kes. 26.78Bn in Q3 2024, driven by a 13.91% rise in total operating income to Kes. 67.38Bn. Profit after tax climbed 12.3% to Kes. 21.56Bn from Kes. 19.21Bn a year earlier. The Board declared an interim dividend of Kes. 1.00 per share, underscoring its solid profitability, strong liquidity, and shareholder value commitment. With stable asset quality, robust capital buffers, and easing funding costs, Co-op Bank remains well positioned for sustained growth and long-term value creation.
- EABL's first-tranche offer under its Kes. 20.00Bn Medium-Term Note Programme closed on 10th November 2025, recording an oversubscription of Kes. 16.76Bn (152.4%) against a target of Kes. 11.00Bn. The brewer has since sought approval from CMA to expand the allotment within the approved programme, underscoring strong investor confidence in its credit profile and the attractiveness of the 11.80% fixed-rate bond.
