Daily Market Wrap 18th November 2025

KINGDOM SECURITIES

Market Indicators: The equities market closed mixed, with NASI easing 0.09% to 187.69, NSE 20 down 0.26% to 3,182.92, and NSE 25 marginally lower at 5,064.84 (-0.04%). Conversely, the NSE 10 edged up 0.02% to 1,952.74, while the Banking Index posted a slight gain of 0.05% to 204.72. Market capitalization dipped 0.09% to Kes. 2.96Trn. Total equity turnover more than doubled, rising 115.28% to Kes. 844.79Mn, buoyed by heightened activity in large-cap counters.

Gainers/Losers: Kenya Power Preferred 4 led gainers, rising 9.98%, followed by Uchumi Supermarket (+9.62%) and Eaagads (+6.33%). On the downside, Longhorn Publishers fell 9.40%, with Crown Paints (-7.11%) and Absa NewGold ETF (-3.38%) also registering notable declines.

Top Movers: Safaricom dominated activity with Kes. 396.05Mn in turnover, followed by Equity Group (Kes. 161.81Mn) and KCB Group (Kes. 106.95Mn).

Foreign Participation: Foreign investors remained net sellers, driven by significant outflows in Safaricom (Kes. -382.45Mn) and Equity Group (Kes. -9.49Mn). Key inflows were recorded in BAT Kenya (Kes. 11.79Mn) and DTB Group (Kes. 2.66Mn).

Bonds Market: Bond turnover in the secondary market rose 18.24% to Kes. 7.65Bn, reflecting improving demand in the fixed-income segment.

Market Update: Absa Bank Kenya released its Q3 2025 results showing a mixed performance, with profit after tax rising 14.68% year-on-year to Kes. 16.92Bn despite margin pressure. Net interest income fell 4.58% as loan yields softened and lending remained subdued, though non-funded income grew 11.15% to Kes. 13.61Bn, helping steady total operating income at Kes. 46.56Bn. Asset quality improved slightly, with the NPL ratio easing to 12.5%, while stronger cost control supported a solid return on equity of 26.85%. Overall, the bank remains resilient, anchored by diversified income streams and balance sheet stability. Read the detailed report here.
