### Daily Market Wrap 3<sup>rd</sup> November 2025

#### **Daily Market Wrap**

- Market Indicators: The equities market opened the week positive, with NASI gaining 0.99% to 190.15, NSE 10 advancing 1.23% to 1,934.23, NSE 20 adding 1.18% to 3,153.39, while NSE 25 climbed 1.09% to 5,052.98. The Banking Index eased 1.43% to 149.92. Market capitalization held steady at Kes. 2,995.83Bn, while total equity turnover rose 2.87% to Kes. 912.14Mn, supported by renewed investor activity.
- **Top Gainers and Losers:** Shri Krishna Overseas led the gainers' chart, up 9.12%, followed by NSE (+8.92%) and Crown Paints Kenya at (+7.96%). On the downside, Nation Media Group declined 5.56%, while Unga Group and Liberty Kenya shed 3.85% and 3.72% respectively.
- **Top Movers**: Safaricom remained the day's top mover with a turnover of Kes. 287.01Mn, followed by Equity Group (Kes. 251.10Mn) and EABL (Kes. 182.95Mn).
- Foreign Participation: Foreign investors were net sellers, with significant outflows in Safaricom (Kes. 205.73Mn) and EABL (Kes. -96.60Mn). Inflows were recorded in KCB Group (Kes. 2.13Mn), Kenya Power (Kes. 0.28Mn), and Stanbic Holdings (Kes. 0.16Mn).
- Bonds Market: The secondary bond market recorded a turnover of Kes. 5.96Bn, down 15.94% from Kes. 7.09Bn in the previous session, reflecting moderated trading ahead of upcoming primary auction announcements.
- Market Update: KCB Group Plc (KCB) announced that on 31 October 2025, it entered into an agreement to acquire a minority stake in Pesapal Limited, a Central Bank of Kenya–licensed payment service provider. This strategic investment is expected to strengthen KCB's presence in the digital payments ecosystem and drive innovation in solutions for Kenya's small and micro enterprises, enhancing value creation for shareholders of both KCB and Pesapal. The transaction reflects KCB's continued commitment to diversifying its income streams and positioning itself for long-term growth in the evolving financial technology space. Completion of the investment remains subject to customary conditions, including receipt of regulatory approvals from the Central Bank of Kenya.
