Daily Market Wrap

Market Indicators: The equities market closed mixed, with NASI shedding 0.56% to 189.08, NSE 10 easing 0.22% to 1,929.88, while NSE 20 rose slightly by 0.23% to 3,160.49. The NSE 25 also declined marginally by 0.07% to 5,049.63. The Banking Index, however, recorded a sharp gain of 34.67% to 201.89, reflecting price recovery across select banking counters. Market capitalization declined to Kes. 2,978.87Bn, while total equity turnover dropped significantly by 66.83% to Kes. 302.59Mn, indicating lower trading activity.

Gainers/Losers: NSE led the gainers' list, climbing 9.04%, followed by Crown Paints (+6.91%) and Carbacid Investments (+4.95%). On the losing end, Sanlam Kenya dropped 5.03%, followed by Absa NewGold ETF (-2.46%) and Standard Group (-2.23%), as investors booked profits on recent rallies.

Top Movers: Safaricom dominated market activity with a turnover of Kes. 67.82Mn, followed by Equity Group (Kes. 59.06Mn) and Kenya Power (Kes. 30.17Mn).

Foreign Participation: Foreign investors were net sellers, registering outflows in Equity Group (Kes. -34.02Mn), Kenya Power (Kes. -13.83Mn), and Safaricom (Kes. -13.50Mn). Net inflows were recorded in Stanbic Holdings (Kes. 0.59Mn) and NCBA Group (Kes. 0.10Mn).

Bonds Market: The secondary bonds market posted improved performance, with turnover rising 101.85% to Kes. 12.03Bn from Kes. 5.96Bn in the previous session.

• Market Update: The November bond offer for FXD1/2012/20 and FXD1/2022/15 to raise Kes. 40.00Bn for budgetary support closes tomorrow, Wednesday, 5th November 2025. The two papers carry coupon rates of 12.00% and 13.94%, respectively, with outstanding balances of Kes. 130.81Bn and Kes. 129.20Bn.

We anticipate an oversubscription driven by attractive yields and limited opportunities in the equities market. Investor preference is expected to tilt toward FXD1/2022/15, given its higher coupon rate. Recent subscription trends suggest continued investor focus on attractive yields over longer durations, reflecting a preference for return optimization in current portfolio allocations.
