#### **Daily Market Wrap**

**Market Indicators:** The equities market closed on a bullish note, with NASI gaining 0.42% to 189.88, NSE 10 adding 1.50% to 1,958.84, while NSE 20 and NSE 25 rose by 0.71% to 3,182.95 and 0.69% to 5084.52 respectively. The Banking Index recorded a gain of 0.64% to 203.18, reflecting sustained interest in select banking counters. Market capitalization increased 0.43% to Kes. 2,991.55Bn, while total equity turnover rose sharply by 121.16% to Kes. 669.22Mn.

**Gainers/Losers:** Sanlam Kenya led the gainers' list, climbing 6.75%, followed by Centum (+4.45%) and EABL (+3.23%). On the losing end, Willamson Tea dropped 8.06%, followed by NCBA Group (-5.93%) and Standard Group (-5.00%).

**Top Movers:** Safaricom continued to dominate market activity with a turnover of Kes. 228.61Mn, followed by Equity Group (Kes. 189.48Mn) and NCBA Group (Kes. 36.23Mn).

**Foreign Participation:** Foreign investors were net sellers, registering outflows in Safaricom (Kes. -217.50Mn), Equity Group (Kes. -90.31Mn), and BAT Kenya (Kes. -3.71Mn). Net inflows were recorded in KCB Group (Kes. 4.34Mn) and NSE (Kes. 1.71Mn).

**Bonds Market:** The secondary bonds market posted a reduced performance, with turnover declining by 43.14% to Kes. 6.84Bn from Kes. 12.03Bn in the previous session.

Market Update: I&M Holdings Plc reached a new all-time high of Kes. 45.05 on November 5, 2025, valuing the group at approximately Kes. 78.39Bn. The milestone reflects its strong fundamentals and consistent regional growth since its transformation from City Trust Limited in 2013. With operations spanning Kenya, Tanzania, Rwanda, Uganda, and Mauritius, the group's steady expansion and prudent management continue to attract investor confidence. Investor outlook remains positive, supported by solid earnings momentum and a sound regional diversification strategy.
