#### Daily Market Wrap 1<sup>st</sup> December 2025

**Market Indicators:** The equities market delivered a mixed performance, with key indices posting both gains and pullbacks. The NASI edged up 0.22% to 181.45, while the NSE 10 and NSE 25 advanced 0.25% and 0.08% to close at 1,853.53 and 4,824.58, respectively. In contrast, the NSE 20 slipped 0.49% to 3,037.86. Banking counters also softened slightly, pushing the Banking Index down 0.07% to 191.78.

Market capitalization nudged upwards to Kes. 2.86Trn, while total equity turnover eased 13.45% to Kes. 528.86Mn.

Gainers/Losers: In the day's price action, Portland Cement led the gainers with a 9.06% jump, followed by Olympia at 8.00%, NMG at 6.58%, BOC at 5.71%, and Jubilee at 4.58%. On the losing end, Eaagads fell 7.32%, with TPS Serena down 6.67%, Car & General slipping 6.49%, Sasini easing 5.91%, and Kenya Re declining 5.68%.

**Top Movers:** Safaricom led market activity with a turnover of Kes.345.88Mn, followed by Sameer Africa at Kes.62.96Mn. EABL posted Kes.15.72Mn, while Kenya Power recorded Kes.12.02Mn. KCB Group registered Kes.10.99Mn, and KenGen closed with Kes.10.09Mn.

**Foreign Participation:** Foreign investors were net sellers, with the largest outflows registered in Safaricom at Kes.336.54Mn, followed by DTB Group with Kes.2.55Mn. Jubilee Holdings saw outflows of Kes.2.30Mn, while EABL and HF Group recorded Kes.1.78Mn and Kes.0.11Mn, respectively.

On the other hand, foreign inflows were comparatively modest. EABL led with Kes.14.47Mn, followed by DTB Group at Kes.7.71Mn, while Equity Group, Carbacid Investments, and Stanbic Holdings posted inflows of Kes.4.34Mn, Kes.4.10Mn, and Kes.3.79Mn, respectively.

**Bonds Market:** Activity in the secondary bonds market improved, with turnover rising 63.47% to Kes. 9.74Bn from Kes. 5.96Bn in the previous session.
