Market Indicators: The equities market closed firmly higher, with NASI gaining 0.30% to 184.54, NSE 10 rising 0.69% to 1,944.78, NSE 20 edging 0.11% to 3,103.09, and NSE 25 advancing 0.57% to 5043.87. The Banking Index added 0.82% to 200.92.

Market capitalization stood at Kes. 2.91Trn, while total equity turnover increased by 76.66% to Kes. 365.40Mn as activity picked across key large-cap counters.

Gainers/Losers: Uchumi Supermarket topped the gainers list, rising 8.86% after a recent prolonged losing streak, followed by Express Kenya (+8.33%) and Eveready East Africa (+6.82%). On the downside, Unga Group declined 8.96%, while TPS Eastern Africa (-8.18%) and Sanlam Kenya (-5.79%) also posted notable losses.

Top Movers: Jubilee Holdings was the day's most traded stock with Kes. 132.27Mn in turnover, followed by Safaricom (Kes. 99.62Mn) and Equity Group (Kes. 32.79Mn).

Foreign Participation: Foreign investors were net sellers, with the notable outflows recorded in Safaricom (Kes. -33.46Mn), Equity Group (Kes. -20.73Mn), and Absa NewGold ETF (Kes. -14.25Mn). On the other hand, net inflows were centered around Carbacid Investments (Kes. 2.44Mn), TPS Eastern Africa (Kes. 0.65Mn), and Williamson Tea Kenya (Kes. 0.12Mn).

Bonds Market: Activity in the secondary bonds market reduced, with turnover falling 46.74% to Kes. 3.92Bn from Kes. 7.36Bn in the previous session, signaling a subdued investor interest in the existing papers.
