Market Indicators: The equities market closed higher, with NASI gaining 0.45% to 185.37. NSE 10 rose 0.35% to 1,951.61, NSE 20 advanced 0.35% to 3,113.86, while NSE 25 added 0.41% to close at 5,064.66. The Banking Index outperformed, climbing 0.68% to 202.28.

Market capitalization increased 0.45% to Kes. 2,925.39Bn, while equity turnover rose 20.57% to Kes. 440.58Mn on improved activity.

Gainers/Losers: Uchumi Supermarket led the gainers with a 9.30% rise, followed by Unga Group (+8.47%) and Home Afrika (+6.72%). On the downside, WPP Scangroup declined 6.06%, E.A. Portland Cement fell 4.75%, while Kakuzi Plc shed 3.62%.

Top Movers: Safaricom was the most traded counter with Kes. 242.45Mn turnover, followed by Equity Group (Kes. 86.32Mn) and Co-op Bank Group (Kes. 26.77Mn).

Foreign Participation: Foreign investors closed the session as net buyers, driven by inflows into Safaricom (Kes. 121.09Mn), KenGen (Kes. 0.20Mn), and DTB Group (Kes. 0.12Mn). Conversely, net selling was concentrated in Equity Group (Kes. -22.51Mn), Co-op Bank (Kes. -0.93Mn), and I&M Group (Kes. -0.19Mn), reflecting subdued foreign investor appetite for select banking counters.

Bonds Market: Activity in the secondary bond market strengthened, with turnover surging 136.22% to Kes. 9.26Bn from Kes. 3.92Bn in the previous session, supported by increased participation toward year-end.
