Daily Market Wrap 9th December 2025

Market Indicators: The equities market closed lower, with NASI easing 1.30% to 176.80, NSE 10 declining 1.36% to 1812.76, NSE 20 slipping 0.79% to 2,929.54, and NSE 25 falling 0.83% to 4,726.25. The Banking Index also retreated 0.63% to 187.16, reflecting broad weakness across banking counters. Market capitalization dipped to Kes. 2.79Trn, while total equity turnover rose sharply to Kes. 1602.70Mn on improved trading activity.

Gainers/Losers: Uchumi Supermarket led the gainers, climbing 5.11%, followed by TPS Eastern Africa, up 4.23%, and DTB Group which added 3.78%. On the downside, East African Portland Cement fell 7.91%, Olympia Capital declined 5.33%, and Co-operative Bank eased 5.18%.

Top Movers: KCB Group dominated activity with Kes. 548.68Mn in turnover, followed by Equity Group at Kes. 424.53Mn, and Safaricom at Kes. 287.98Mn.

Foreign Participation: Foreign investors were net buyers, with the biggest inflows recorded in Safaricom (Kes. 108.50Mn), Equity Group (Kes. 38.76Mn), and DTB Group (Kes. 1.84Mn). On the other hand, net outflows were centered around KCB Group (Kes. -88.58Mn), Stanbic Holdings (Kes. -47.44Mn), and Stan Chart Bank (Kes. -8.91Mn).

Bonds Market: Activity in the secondary bonds market increased, with turnover rising 40.27% to Kes. 15.36Bn from Kes. 10.95Bn in the previous session, signaling an increased investor interest in long-duration papers.

Market Update: The Central Bank of Kenya's Monetary Policy Committee (MPC) meets today (9 December 2025) to review the 9.25% policy rate, with the decision likely guided by cooling inflation, stable FX conditions, and modest private-sector credit growth. With inflation now well below the 5-year average of 6.02% and policy already eased by a cumulative 375bps, there is room for at least a 25bps cut, which would bring the CBR to 9.0% by year-end. The Committee has maintained a steady rhythm of 25bps reductions across the last three meetings, in line with the continued stability of inflation relative to the CBK's midpoint target.
