

**Market Indicators:** The equities market extended gains, with all major indices closing in positive territory, albeit at a more measured pace. The NASI edged up 0.31% to 191.27, while the NSE 10 rose 0.45% to 2,025.73. The NSE 20 and NSE 25 added 0.46% and 0.16% to close at 3,198.42 and 5,239.13, respectively. The Banking Index advanced 0.27% to 210.17, signaling continued, though selective, interest in banking counters.

Market capitalization expanded by 0.31% to Kes. 3,018.46 Bn.

**Trading Activity:** Activity strengthened further, with total shares traded rising 7.92% to 30.37 Mn, while equity turnover climbed 18.18% to Kes. 963.11 Mn supported by sustained participation in large-cap names.

**Gainers/Losers:** E.A. Portland Cement led the gainers, surging 7.22%, followed by Home Afrika (+6.98%), Umeme (+5.96%), Kenya Re (+5.32%) and Co-operative Bank (+4.04%). On the downside, Shri Krishna Overseas topped the losers, retreating 7.64%.

**Top Movers:** Safaricom remained the most actively traded counter with a turnover of Kes. 414.84 Mn followed by Equity Group (Kes. 264.19 Mn) and KCB Group (Kes. 74.98 Mn).

**Foreign Participation:** Foreign investors were net buyers, with notable buying interest in Equity Group (Kes. 234.97 Mn) and Safaricom (Kes. 214.34 Mn). On the sell side, there was heavy foreign outflows in Safaricom (Kes. 344.58 Mn).

**Bonds Market:** The secondary bond market recorded a sharp rebound, with turnover surging 559.08% to Kes. 12.61 Bn from Kes. 1.91 Bn in the previous session.
