

**Market Indicators:** The equities market closed firmly positive, with broad-based gains across all major indices. The NASI rose 0.55% to 194.49, while the NSE 10 edged up 0.07% to 2,024.91. The NSE 20 gained 0.60% to 3,270.85, with the NSE 25 outperforming, up 0.85% to 5,299.15. The Banking Index recorded a strong advance of 1.12% to 215.33, largely driven by gains on NCBA Group.

Market capitalization expanded 0.55% to Kes. 3,069.34Bn, reflecting improved market breadth.

**Trading Activity:** Market participation softened modestly. Total equity turnover declined 9.96% to Kes. 675.72Mn, while volumes traded eased 11.11% to 17.02Mn shares, pointing to lighter activity following the previous session's elevated trading.

**Gainers/Losers:** Kenya Airways led the gainers' board, rallying 9.62%, closely followed by NCBA Group, which surged 9.47% after Nedbank announced its intention to acquire a controlling stake in the lender. On the downside, Standard Group topped the losers, shedding 7.74%.

**Top Movers:** Trading activity was led by BAT Kenya, which posted Kes. 157.90Mn in turnover. Absa NewGold ETF followed with Kes. 101.58Mn, while Equity Group recorded Kes. 74.39Mn. Safaricom, NCBA Group, and Co-operative Bank also featured among the most active counters.

**Foreign Participation:** Foreign investor activity declined sharply, to Kes. 161.05Mn, from Kes. 273.12Mn in the previous session. Foreign buys plunged 96.65% to Kes. 10.15Mn, while foreign sales fell 70.0% to Kes. 171.19Mn.

Foreign buying was concentrated in Kenya Power, Safaricom, and EABL, while foreign selling was dominated by Absa NewGold ETF, EABL, and Safaricom.

**Bonds Market:** Activity in the secondary bonds market remained subdued, with turnover easing 1.70% to Kes. 17.39Bn, marginally lower than the prior session.

**Nedbank** has issued a firm notice of intention to acquire a 66.0% controlling stake in **NCBA Group**, at an offer price of KES 98.25 per share, valuing NCBA at approximately KES 62.8 billion in equity value. The consideration structure combines cash and Nedbank Group shares, allowing NCBA shareholders to crystallize immediate value while retaining exposure to the growth prospects of one of Africa's largest banking groups. Importantly, NCBA **will remain listed** on the Nairobi Securities Exchange, retain its brand identity, and continue operating as a Kenyan-headquartered institution, ensuring continuity for customers, employees, and the local capital market.
