

**Market Indicators:** The equities market closed marginally positive, with gains recorded across most headline indices, although performance was mixed. The NASI inched up 0.06% to 194.60, while the NSE 10 gained 0.19% to 2,028.78. The NSE 25 rose 0.05% to 5,301.84, and the Banking Index advanced 0.21% to 215.78, supported by steady activity in tier-one lenders. In contrast, the NSE 20 slipped 0.11% to 3,267.15.

Market capitalization edged up 0.06% to Kes. 3.07Trn, reflecting the mildly positive tone.

**Trading Activity:** Market participation was mixed. Volumes traded increased 2.53% to 17.45Mn shares, while total equity turnover declined 5.20% to Kes. 640.59Mn, indicating selective participation and lighter value trades.

**Gainers/Losers:** Eaagads led the gainers' board, rising 9.37%, followed by Standard Group (+7.69%) and Eveready East Africa (+7.20%). On the downside, BOC Kenya topped the losers, shedding 8.52%, while BK Group declined 4.78%.

**Top Movers:** Trading activity was led by Equity Group, which posted Kes. 178.93Mn in turnover, followed by Safaricom (Kes. 128.20Mn) and Stanbic Holdings (Kes. 92.24Mn). KCB Group and BAT Kenya also featured among the most active counters.

**Foreign Participation:** Foreign investor activity rebounded sharply, with net foreign flows turning positive at Kes. 34.97Mn, from a net outflow in the prior session. Foreign buys surged to Kes. 218.72Mn, while foreign sales rose modestly to Kes. 183.75Mn.

Foreign buying was concentrated in Equity Group, Stanbic Holdings, and Kenya Power, while foreign selling was dominated by Stanbic Holdings, Safaricom, and KCB Group.

Foreign buying was concentrated in Kenya Power, Safaricom, and EABL, while foreign selling was dominated by Absa NewGold ETF, EABL, and Safaricom.

**Bonds Market:** Activity in the secondary bonds market weakened, with turnover declining 34.31% to Kes. 11.43Bn, from the previous session.
