

Market Indicators: The equities market closed firmly positive, with gains recorded across all major indices, reflecting sustained buying interest across large-cap and banking stocks. The NASI rose 0.39% to 195.71, while the NSE 25 advanced 0.58% to 5,328.58. The NSE 10 and NSE 20 gained 0.23% and 0.18% to 2,048.07 and 3,289.12, respectively, underscoring broad-based market participation. The Banking Index climbed 0.56% to 217.34, signaling renewed demand for tier-one lenders.

Overall market capitalization increased 0.39% to Kes. 3.09Trn, mirroring the positive close.

Trading Activity: Market activity moderated, with volumes traded declining 38.08% to 20.19Mn shares, while equity turnover fell 42.90% to Kes. 590.31Mn, suggesting reduced participation in high-value counters. Activity in the fixed income market also eased.

Gainers/Losers: Sanlam Kenya led the gainers' board, rallying 7.33%, followed by NCBA Group (+5.28%) and Absa NewGold ETF (+4.68%). On the downside, Britam Plc led the laggards, shedding 5.25%, while Crown Paints Kenya (-5.22%) and NBV (-3.45%) also closed lower.

Top Movers: Trading activity was dominated by Absa NewGold ETF, which accounted for Kes. 398.40Mn in turnover. Equity Group followed with Kes. 157.04Mn, while KCB Group recorded Kes. 102.90Mn, highlighting sustained interest in select heavyweights.

Foreign Participation: Foreign investor sentiment strengthened markedly, with foreign buys surging 95.24% to Kes. 543.71Mn, while foreign sales declined sharply by 79.82% to Kes. 34.67Mn. This resulted in net foreign inflows of Kes. 509.04Mn, indicating strong offshore demand. Foreign buying was concentrated in Absa NewGold ETF, Equity Group, and KCB Group.

Bonds Market: Activity in the secondary bonds market softened, with bond turnover easing to Kes. 10.53Bn from Kes. 17.85Bn in the previous session.

Moody's has upgraded Kenya's sovereign credit rating to B3 from Caa1 and revised the outlook to stable, citing a reduced near-term default risk. The upgrade reflects stronger foreign exchange reserves of USD 12.2bn (equivalent to 5.3 months of import cover), successful Eurobond buybacks, and improved liquidity buffers that have eased near-term fiscal pressures.

The agency also noted a moderation in domestic financing costs. However, it emphasized that structural challenges persist, including elevated interest payments consuming over 30% of government revenue, fiscal deficits of around 6% of GDP, revenue underperformance, and institutional weaknesses such as corruption. In addition, downside risks remain, notably from climate-related shocks and potential social unrest.
