

Market Indicators: The equities market closed broadly positive, with all key indices ending higher except the Banking Index, which softened on mild profit-taking. The NASI gained 0.16% to 195.36, while the NSE 10 advanced 0.30% to 2,046.82, NSE 20 added 0.13% to 3,299.28, and NSE 25 rose 0.27% to 5,321.96. The Banking Index eased 0.50% to 215.03.

Market capitalization increased marginally to Kes. 3,083.07Bn (+0.16%).

Trading Activity: Market activity slowed sharply, with total equity turnover declining 60.26% to Kes. 352.18Mn, while volumes traded fell 64.69% to 9.16Mn shares, signalling subdued participation despite the positive close.

Gainers/Losers: EABL led the gainers' board, rising 5.40%, followed by Uchumi Supermarket (+3.25%). On the downside, Kenya Airways topped the losers, shedding 6.76%, alongside Olympia Capital (-6.06%) and Absa NewGold ETF (-5.53%).

Top Movers: Absa NewGold ETF was the most actively traded counter, posting Kes. 396.49Mn in turnover. This was followed by Equity Group (Kes. 154.16Mn) and KCB Group (Kes. 102.51Mn), underscoring concentration in a few large counters.

Foreign Participation: Foreign investor activity moderated significantly, with foreign buys dropping to Kes. 84.20Mn and sales to Kes. 77.20Mn. The market nonetheless recorded net foreign inflows of Kes. 7.00Mn, supported largely by buying interest in Equity Group (Kes. 71.98Mn) and Safaricom (Kes. 8.13Mn). Foreign selling was concentrated in Equity Group (Kes. 49.98Mn) and DTB Group (Kes. 10.16Mn).

Bonds Market: Activity in the secondary bond market eased, with turnover declining 15.57% to Kes. 15.92Bn.

Umeme Limited has issued a profit warning, indicating that it will likely record a loss for the year ended 31 December 2025, marking a second consecutive annual loss following losses reported in 2024. The anticipated loss is primarily attributed to the cessation of operating revenue after the natural expiry of its 20-year electricity distribution concession in Uganda on 31 March 2025, which ended revenue generation at the close of Q1 2025. The company is currently pursuing outstanding compensation claims against the Government of Uganda through the dispute resolution mechanisms provided under the Privatization Agreements, with further details expected to be disclosed in the forthcoming audited financial statements
