Market Indicators: The equities market closed mixed, with NASI edging down 0.11% to 191.87 and NSE 10 easing 0.49% to 2,022.61. NSE 20 outperformed, rising 0.39% to 3,233.75, while NSE 25 declined 0.35% to 5,245.74. The Banking Index posted marginal gains of 0.14% to 211.72.

Market capitalization slipped 0.11% to Kes. 3,027.94Bn, while equity turnover rose sharply by 49.32% to Kes. 893.29Mn on improved trading activity.

Gainers/Losers: Unga Group topped the gainers' chart, advancing 6.78%, followed by Eveready East Africa (+6.20%) and BK Group (+3.74%). On the downside, Uchumi Supermarket declined 4.92%, Standard Group fell 4.87%, while EABL shed 3.50%.

Top Movers: Safaricom led market activity with Kes. 392.36Mn turnover, followed by KCB Group at Kes. 133.51Mn and Equity Group at Kes. 111.11Mn.

Foreign Participation: Foreign investors were net sellers, with notable net inflows recorded in Equity Group (Kes. 99.12Mn), Kenya Power (Kes. 10.31Mn), and Carbacid Investments (Kes. 1.45Mn). However, significant net outflows were observed in Safaricom (Kes. -188.56Mn), EABL (Kes. -20.22Mn), and KenGen (Kes. -9.55Mn), reflecting selective foreign positioning.

Bonds Market: The secondary bonds market recorded a strong rebound in activity, with turnover surging 70.06% to Kes. 13.69Bn from Kes. 8.05Bn in the previous session.
