

Market Indicators: The equities market closed decisively higher, with all key indices ending firmly in the green on the back of strong buying interest, particularly in large-cap counters. The NASI surged 1.98% to 202,31, while the NSE 10 rose 1.28% to 2,095.85. The NSE 20 advanced 0.70% to 3,340.06, NSE 25 gained 1.18% to 5,437.33, and the Banking Index strengthened 0.61% to 218.19.

Market capitalization expanded sharply by 2.00% to Kes. 3,192.76Bn.

Trading Activity: Market activity rebounded strongly, with equity turnover jumping 67.01% to Kes. 1,289.85Mn, while volumes traded rose 85.05% to 34.37Mn shares, signalling broad-based participation alongside the rally.

Gainers/Losers: Kenya Orchards led the gainers, climbing 9.97%, followed by Longhorn Publishers (+8.12%) and Eaagads (+5.20%). On the downside, Express Kenya topped the losers' board, declining 5.98%, alongside Standard Group (-4.62%) and Jubilee Holdings (-2.91%).

Top Movers: Safaricom dominated activity with a turnover of Kes. 614.56Mn, accounting for nearly half of total market turnover. This was followed by Equity Group (Kes. 221.26Mn) and I&M Group (Kes. 71.78Mn), underscoring sustained investor focus on select blue-chip stocks.

Foreign Participation: Foreign investors remained net sellers, with net outflows widening to Kes. 388.86Mn. Foreign purchases dropped sharply 71.65% to Kes. 64.34Mn, while sales rose 23.53% to Kes. 453.21Mn. Selling pressure was led by Safaricom (Kes. 369.19Mn) and BAT Kenya (Kes. 45.68Mn), while net foreign inflows were recorded in Equity Group and KCB Group.

Bonds Market: Activity in the secondary bond market softened, with turnover declining 26.30% to Kes. 10.07Bn, from Kes. 13.67Bn, in the previous trading session.

Safaricom PLC has announced the declaration of an interim dividend of Kes. 0.85 per ordinary share for the financial year ending 31 March 2026, following a resolution by its Board at a meeting held on 4 February 2026. The dividend will be payable to shareholders whose names appear on the register at the close of business on 25 February 2026, with payment scheduled on or about 31 March 2026.
