

**Market Indicators:** The equities market closed firmly higher, extending gains on broad-based index performance and continued strength in banking counters. The NASI advanced 0.56% to 205.08, while the NSE 20 gained 0.37% to 3,386.34 and the NSE 25 rose 0.38% to 5,506.63. The NSE 10 also edged up 0.28% to 2,112.24. The Banking Index outperformed the broader market, climbing 0.71% to 222.78.

Market capitalization expanded by 0.56% to Kes. 3.24Trn, reflecting improved investor sentiment.

**Trading Activity:** Market participation rebounded sharply, with equity turnover surging 326.09% to Kes. 2.44Bn, while volumes traded jumped 273.05% to 59.61Mn shares. The spike points to renewed activity, largely driven by large-cap banking stocks and heightened foreign participation.

**Gainers/Losers:** Sasini Plc topped the gainers' board, rallying 9.93%, followed closely by Limuru Tea (+9.87%), Sameer Africa (+9.71%), Eveready East Africa (+9.23%), and E.A. Portland Cement (+7.87%). On the downside, BK Group led the laggards, shedding 5.36%, while NBV (-4.73%), Flame Tree Group (-2.22%), BOC Kenya (-2.15%), and TPS Eastern Africa (-1.90%) also closed lower.

**Top Movers:** Equity Group dominated trading activity with a turnover of Kes. 808.91Mn, followed by NCBA Group (Kes. 487.93Mn) and Co-op Bank Group (Kes. 445.41Mn). Safaricom, ABSA Bank Kenya, and I&M Group also featured among the most actively traded counters, underscoring sustained interest in large-cap names.

**Foreign Participation:** Foreign investors significantly increased participation, recording net inflows of Kes. 279.29Mn compared to Kes. 27.40Mn in the previous session. Foreign purchases surged 1,532.54% to Kes. 649.22Mn, while foreign sales jumped to Kes. 369.93Mn. Net inflows were driven mainly by Equity Group, with support from I&M Group and Jubilee Holdings. Net outflows were recorded in ABSA Bank Kenya, Safaricom, NCBA Group, BAT Kenya, and EABL.

**Bond Market:** Activity in the secondary bond market improved further, with turnover rising 13.81% to Kes. 15.23Bn, pointing to sustained demand across the fixed-income space.
