

**Market Indicators:** The equities market extended its rally, closing higher with broad-based gains across all major indices. The NASI advanced 1.72% to 216.69, while the NSE 20 gained 3.06% to 3,633.13 and the NSE 25 rose 2.56% to 5,855.41. The NSE 10 climbed 2.70% to 2,252.01, while the Banking Index added 2.82% to 237.12.

Market capitalization rose 1.72% to Kes. 3.42Trn.

**Trading Activity:** Activity eased, with volumes traded declining 9.78% to 48.03Mn shares. Equity turnover dipped 2.59% to Kes. 1.23Bn, reflecting slightly reduced participation.

**Gainers/Losers:** Kenya Re led gainers, surging 9.91%, followed by NSE (+9.88%), TPS Eastern Africa (+9.85%), Car & General (K) (+9.26%), and CIC Insurance (+9.09%).

On the downside, Limuru Tea topped losers, easing 2.67%, followed by E.A.Portland (-1.52%), Kenya Orchards (-1.25%), Liberty Kenya (-0.70%), and Kenya Airways (-0.36%).

**Top Movers:** KCB Group dominated turnover with Kes. 343.11Mn, followed by Equity Group (Kes. 170.56Mn), Safaricom (Kes. 112.98Mn), KenGen (Kes. 75.46Mn), and NSE (Kes. 74.74Mn).

**Foreign Participation:** Foreign investors turned net sellers, posting net outflows of Kes. 379.88Mn versus prior inflows. Foreign purchases fell 41.24% to Kes. 171.58Mn, while sales surged 238.55% to Kes. 551.46Mn.

Top foreign sells included KCB Group (Kes. 160.95Mn), Equity Group (Kes. 124.20Mn), and NSE (Kes. 67.85Mn) while inflows were notable in KCB Group, Stanbic and Equity. Net outflows concentrated in Equity Group (-Kes. 112.87Mn), KCB Group (-Kes. 73.81Mn), and NSE (-Kes. 67.85Mn).

**Bond Market:** Secondary bond turnover rose 24.97% to Kes. 18.46Bn.
