

Market Indicators: The equities market extended losses, with all major indices closing in negative territory. The NASI declined 0.62% to 209.88, while the NSE 10 fell 0.78% to 2,172.95. The NSE 20 eased 0.51% to 3,622.57, the NSE 25 shed 0.75% to 5,701.79, and the Banking Index retreated 0.99% to 232.53.

Market capitalization contracted 0.62% to Kes. 3.31Trn from Kes. 3.33Trn previously, reflecting continued selling pressure in select large-cap counters.

Trading Activity: Activity remained subdued during the session. Shares traded declined 3.66% to 25.87Mn, while equities turnover fell 6.33% to Kes. 698.29Mn.

Gainers/Losers: Shri Krishna Overseas led the gainers with a 9.45% advance, followed by Uchumi Supermarket (+6.98%), Centum (+3.04%), Car & General (+2.83%), and Flame Tree Group (+2.54%).

On the downside, Sasini Plc topped the losers with an 8.45% decline, trailed by Eveready (-7.53%), Crown Paints (-4.38%), BOC Kenya (-4.14%), and Sameer Africa (-4.12%).

Top Movers: BK Group dominated turnover at Kes. 162.87Mn, followed by Safaricom (Kes. 136.58Mn) and KCB Group (Kes. 96.39Mn). Additional activity was recorded in BAT Kenya (Kes. 41.11Mn) and Kenya Power (Kes. 38.41Mn).

Foreign Participation: Foreign investors remained net sellers, with net outflows widening significantly to Kes. 204.54Mn from Kes. 47.44Mn previously. Foreign purchases surged 130.76% to Kes. 140.46Mn, while foreign sales more than tripled (+218.55%) to Kes. 345.01Mn.

Top foreign buys were recorded in BK Group (Kes. 92.00Mn) and KCB Group (Kes. 37.39Mn). However, selling pressure was heavily concentrated in Safaricom (Kes. 102.79Mn), BK Group (Kes. 162.60Mn), and BAT Kenya (Kes. 39.75Mn).

KCB Group registered the largest net inflows (+Kes. 29.40Mn), while Safaricom posted the biggest net outflows (-Kes. 99.71Mn).

Bonds: Secondary bond turnover dropped sharply by 27.71% to Kes. 20.94Bn.
