

Market Indicators: The equities market recorded a mixed but largely stable performance, with most indices posting marginal gains. The NASI edged down 0.13% to 206.80, while the NSE 10 rose 0.10% to 2,186.33 and the NSE 25 gained 0.07% to 5,737.18. The NSE 20 inched up 0.03% to 3,613.23, while the Banking Index advanced 0.21% to 237.89, supported by gains in select banking counters.

Market capitalization increased 3.19% to Kes. 3,372.07Bn.

Trading Activity: Trading activity remained relatively subdued, with shares traded declining 1.09% to 34.94Mn. However, equities turnover edged up 0.55% to Kes. 1,061.26Mn, indicating slightly higher value trades despite lower volumes.

Gainers and Losers: Uchumi Supermarket (+9.89%) topped the gainers' chart, followed by Home Afrika (+7.59%) and Flame Tree Group (+5.65%). On the downside, Shri Krishna (-8.79%) emerged as the top loser, followed by Car & General (-5.80%) and BOC Kenya (-3.58%).

Top Movers: Trading activity was dominated by Equity Group, which posted Kes. 355.84Mn in turnover, followed by KCB Group (Kes. 308.25Mn) and Safaricom (Kes. 91.66Mn). Other notable contributors included EABL (Kes. 71.50Mn) and Kenya Airways (Kes. 45.86Mn).

Foreign Participation: Foreign investor remained net sellers, with the market recording net outflows of Kes. 452.08Mn, compared to net outflows of Kes. 205.30Mn in the previous session. Net inflows were mainly recorded in Kenya Power (Kes. 10.17Mn) and BK Group (Kes. 2.67Mn). On the other hand, the largest net outflows were recorded in Equity Group (Kes. 203.80Mn), KCB Group (Kes. 173.70Mn), and Safaricom (Kes. 69.90Mn).

Bonds: Activity in the secondary bonds market strengthened further, with turnover rising 35.14% to Kes. 15.28Bn, up from Kes. 11.31Bn recorded in the previous session.

Earnings Update: We expect Stanbic and KCB full year results tomorrow.
