

Market Indicators: The equities market closed mixed. The NASI edged down 0.33% to 215.36, while the NSE 10 gained 0.15% to 2,271.75. The NSE 20 rose 0.22% to 3,758.73, the NSE 25 was broadly flat at 5,948.05, and the Banking Index eased 0.47% to 244.74.

Market capitalization declined 0.34% to KES 3.40Trn, reflecting mild profit-taking in select large-cap counters.

Trading Activity: Activity softened notably. Shares traded fell 28.66% to 36.01Mn, while equities turnover declined 18.05% to KES 910.75Mn, pointing to cautious participation.

Gainers/Losers: Home Afrika led the gainers with a 10.00% jump, followed by BK Group (+6.43%), Flame Tree Group (+6.01%), Absa NewGold ETF (+5.22%), and Unga Group (+5.17%). On the downside, Uchumi (-7.51%) posted the steepest loss, followed by Eveready East (-6.19%), Kenya Airways (-6.07%), Eaagads (-4.15%), and KCB Group (-3.12%).

Top Movers: Equity Group dominated turnover at KES 421.82Mn, closing unchanged at KES 77.25. I&M Group traded KES 131.60Mn as the counter declined to KES 49.55. EABL advanced to KES 268.75 on turnover of KES 124.23Mn.

Activity was also noted in KenGen (KES 27.02Mn), Safaricom (KES 24.48Mn), and KCB Group (KES 24.26Mn).

Foreign Participation: Foreign investors turned net buyers, recording net inflows of KES 134.33Mn, a reversal from the prior session's net outflows. Foreign purchases dipped 3.82% to KES 332.97Mn, while foreign sales declined sharply by 72.42% to KES 198.64Mn. Equity Group attracted the bulk of foreign inflows (KES 181.95Mn net), while the largest net outflows were recorded in EABL.

Bonds: Secondary bond turnover declined 48.62% to KES 12.46Bn, suggesting reduced activity in fixed income relative to the previous session.
