

**Market Indicators:** The equities market closed on a mixed note, with performance across indices largely subdued. NASI edged down 0.05% to 195.38, while NSE 10, NSE 20, and NSE 25 posted modest gains of 0.22%, 0.32%, and 0.08% respectively. The Banking Index rose 0.62% to 223.30, reflecting mild buying interest in banking stocks. Market capitalization dipped slightly by 0.05% to Kes. 3,240.14Bn. Trading activity weakened, while equity turnover fell 44.10% to Kes. 390.80Mn.

**Gainers/Losers:** Eveready East Africa led the gainers, advancing 9.17%, followed by Africa Mega Agricorn (+9.03%) and Sanlam Kenya (+8.44%). On the downside, Jubilee Holdings topped the losers' chart, shedding 6.54%, followed by Unga Group (-6.10%) and E.A Portland Cement (-5.88%).

**Top Movers:** Equity Group dominated trading activity with Kes. 81.07Mn in turnover, followed by Safaricom at Kes. 52.71Mn and BAT Kenya at Kes. 36.78Mn.

**Foreign Participation:** Foreign investors remained net sellers, with modest inflows recorded in Stan Chart Bank (Kes. 0.39Mn), Kenya Power (Kes. 0.08Mn), and NSE (Kes. 0.06Mn). However, outflows were more pronounced, led by Equity Group (Kes. -36.29Mn), Safaricom (Kes. -32.88Mn), and BAT Kenya (Kes. -31.88Mn), indicating continued foreign exit from key large-cap counters.

**Bonds Market:** The secondary bonds market recorded a strong rebound in activity, with turnover surging 112.93% to Kes. 13.15Bn, up from Kes. 6.18Bn in the previous session.
