

Market Indicators: The equities market closed slightly higher, with modest gains across key indices, signaling a mild recovery in sentiment. NASI rose 0.17% to 208.48, while NSE 10, NSE 20 and NSE 25 advanced by 0.16%, 0.10% and 0.11% to 2,184.18, 3,613.57 and 5,782.25, respectively. The Banking Index also edged up 0.10% to 241.77, indicating stable performance in banking counters.

Market capitalization increased by 0.17% to Kes. 3,457.33Bn.

Trading activity remained subdued, with equities turnover declining 41.90% to Kes. 484.04Mn, while volumes traded fell 33.73% to 19.73Mn shares, pointing to continued caution among investors.

Gainers/Losers: BOC Kenya led the gainers' chart with a 4.83% increase, followed by Uchumi Supermarket (+3.26%) and Unga Group (+3.23%). Sasini Plc (+2.20%) and Total Energies Kenya (+1.76%) also posted gains.

On the downside, Eaagads emerged as the top loser, shedding 6.82%, followed by Olympia Capital (-5.73%) and Kenya Airways (-5.52%). Longhorn (-3.73%) and Nation Media Group (-3.41%) also recorded losses.

Top Movers: Centum dominated trading activity with Kes. 84.25Mn in turnover, followed by Safaricom (Kes. 69.06Mn) and Kenya Power (Kes. 56.10Mn). Equity Group, KCB Group, and Stan Chart Bank recorded Kes. 40.76Mn, Kes. 39.66Mn, and Kes. 37.63Mn, respectively.

Foreign Participation: Foreign investors remained net sellers, posting outflows of Kes. 42.16Mn, albeit a narrower position compared to Kes. 128.40Mn in the previous session.

Foreign purchases declined sharply by 78.16% to Kes. 119.25Mn, while sales dropped 76.07% to Kes. 161.41Mn, reflecting reduced foreign participation overall.

Outflows were primarily driven by Safaricom (Kes. -17.70Mn) and Equity Group (Kes. -15.80Mn), while inflows were concentrated in KCB Group (Kes. 16.81Mn).

Bonds Market: The secondary bonds market recorded strong activity, with turnover rising 69.80% to Kes. 13.51Bn, signaling a continued tilt towards fixed income amid subdued equity market participation.
