

**Market Indicators:** The equities market extended last week's bearish run, with all major indices closing lower. NASI declined by 0.77% to 203.76, while NSE 10, NSE 20, and NSE 25 dropped 1.17%, 1.24%, and 1.08% to 2,109.97, 3,503.52, and 5,606.54, respectively. The Banking Index slipped 1.89% to 231.67. Market capitalization eased by 0.77% to Kes. 3,379.11Bn.

**Trading activity** declined, with volumes falling marginally 1.98% to 17.50Mn shares, while turnover dropped 12.76% to Kes. 737.70Mn, signalling low investor sentiment.

**Gainers/Losers:** Car & General retained last session's gaining spot, advancing 9.59%, followed by Longhorn (+5.41%) and Africa Mega Agricorp (+4.62%). On the downside, Flame Tree Group (-10.28) topped the losers' chart, followed by Absa Bank (-6.72%) and Stan Chart (-6.70%).

**Top Movers:** BK Group dominated trading activity with Kes. 388.87Mn in turnover, followed by Equity Group (Kes. 121.09Mn), and KCB Group (Kes. 42.01Mn), signaling a sustained investor sentiment in the banking counters.

**Foreign Participation:** Foreign investors were net buyers, with net inflows of Kes. 17.71Mn.

Top inflows were recorded in Jubilee Holdings (Kes. 31.85Mn), KenGen (Kes. 6.51Mn), and Co-op Bank (Kes. 2.92Mn). On the other hand, outflows were concentrated in Equity Group (Kes. -22.67Mn), followed by BAT Kenya (Kes. -2.20Mn) and Kapchorua Tea (Kes. -13.90Mn).

**Bonds Market:** Secondary bond market turnover declined 41.45% to Kes. 3.76Bn from Kes. 6.42Bn in the previous session, reflecting subdued activity ahead of the reopened primary market offer deadline.

### Market Updates:

**NCBA Group Plc** has announced that Nedbank Group Limited's partial takeover offer will open on 28 May 2026 and close on 10 July 2026, allowing shareholders to tender up to 66% of their holdings at an implied value of about Kes. 105 per share, payable in a mix of cash and Nedbank shares. Investors can participate through <https://nedbankoffer.candr.africa/>, with results expected by 21 July 2026.

**Shri Krishana Overseas** reported a weaker FY2025 performance, with profit before tax declining 57.46% to Kes. 8.32Mn from Kes. 19.56Mn in FY2024. The slowdown reflects a challenging operating environment marked by tight domestic liquidity, delayed payments across the value chain, and cautious spending by manufacturers.

**Express Kenya Plc** reported a weaker FY2025 performance, with loss after tax widening by 14.12% to Kes. 155.68Mn from Kes. 136.42Mn in FY2024. Revenue declined 19.38% to Kes. 21.27Mn, largely due to reduced rental income following the commencement of construction for a strip mall and filling station on part of its former storage facility, which temporarily impacted occupancy levels.
