

**Market Indicators:** The equities market closed higher during the session, with gains recorded across all major benchmark indices. NASI advanced 0.60% to 224.15, while NSE 10, NSE 20, NSE 25 and the Banking Index gained 0.94%, 0.34%, 0.66% and 0.68% to close at 2,409.62, 3,755.44, 6,208.91 and 255.11, respectively. Consequently, market capitalization rose 0.60% to KES 3,761.74Bn.

**Trading Activity:** Trading activity was mixed across the markets. Equity volumes traded declined sharply by 91.18% to 6.06Mn shares, while equity turnover rebounded to KES 208.15Mn, up 4,309.18% from the previous session's exceptionally low base. Meanwhile, bond market turnover eased 15.44% to KES 11.65Bn.

**Gainers/Losers:** Total Energies Kenya topped the gainers' chart with a 4.43% appreciation, followed by KPC (3.28%), Olympia Capital (2.94%), BOC Kenya (2.87%) and KCB Group (2.61%). On the losers' side, Umeme Ltd posted the steepest decline, shedding 4.66%, followed by Standard Group (3.93%), Eaagads (3.44%), Family Bank (3.01%) and WPP Scangroup (2.79%).

**Top Movers:** Safaricom dominated trading activity with a turnover of KES 204.72Bn, followed by Equity Group (KES 2.69Bn), KCB Group (KES 271.91Mn), I&M Group (KES 202.15Mn) and ABSA Bank Kenya (KES 108.05Mn).

**Foreign Participation:** Foreign investors turned net sellers, recording net outflows of KES 238.05Mn compared to net inflows of KES 95.27Mn in the previous session. Foreign purchases declined 72.96% to KES 357.04Mn, while foreign sales fell 51.42% to KES 595.09Mn. Safaricom recorded the highest foreign net inflows at KES 32.32Mn, while Equity Group registered the largest foreign net outflows at KES 102.76Mn.
